WHEREAS the above bonded principal has entered into this contract with the Arizona Crop Improvement Association dated _____ to perform the following duties: (1) Supervise the storage of various lots of seed separately, or group lots of seed under a grower number or group grower number, or any designation that might be ordered by the Arizona Crop Improvement Association; (2) Supervise the planting, harvesting, and conditioning of the seed so that mixtures will not occur; (3) supervise the tagging and sealing so that seed will not be without identification at any point in the warehouse; (4) Supervise the taking of adequate samples that will fairly represent each lot of seed; (5) Execute the Grower-Warehouse Certificate accurately; (6) Report annually the amount of recleaned seed obtained from each lot or group of lots of seed cleaned; (7) To return all unused Certified or Registered tags to the Arizona Crop Improvement Association, which contract is hereby referred to and made a part hereof as fully and to the same extent as if copied at length herein.

The surety shall have the right to withdraw as surety from this bond except as to any liability incurred or accrued by giving the Arizona Crop Improvement Association thirty days period of notice the bond shall terminate except as to any liabilities or indebtedness incurred prior to said date of termination.

NOW, THEREFORE, the conditions of the above obligation are such that if _____ shall in all things stand to and abide by and well and truly keep and perform the covenants, conditions, and agreements of this contract upon his part to be kept and performed at the time and in the manner specified in said contract, then this obligation to be null and void, otherwise to be and remain in full force and effect.

IT IS hereby understood and agreed that the liability of this bond shall not exceed one thousand and no/100 dollars (\$1,000).
